Dear Dockless Bike-Share Operators:

Your recent deployment of dockless bicycles and scooters has caught the attention of my District Three communities, both generating interest and raising concerns. Since the neighborhoods I represent are an ideal location for cycling and alternative modes of transit, I want to ensure that the public is properly informed of responsible usage and placement. To this end, I ask that you meet with the many active community groups in my district to provide an informational presentation at their upcoming meetings and respond to questions and concerns.

To help guide your outreach and facilitate these conversations, I have included a list of a number of local community organizations and their meeting dates. While still in the early stages of your launch, it is important to communicate with the many business improvement districts (BIDs) and maintenance assessment districts (MADs) regarding liability in the public right of way. In order for the BIDs and MADs to continue successfully managing and programming our streets and sidewalks, they should have a local contact with your business that can address immediate issues.
